

**Proceedings of the Secretary, Hyderabad Karnataka Region
Development Board, Kalaburagi**

Sub: Regarding the implementation of HKRDB, Plan.

Preamble

As per the Chapter - III, rule 16 of the Hyderabad-Karnataka Region Development Board Order 2013, the Board shall be responsible for the implementation of schemes included in its plan through the development departments, Zilla Panchayats, Urban local bodies and non-Governmental organizations recognized by the Board functioning in the Hyderabad Karnataka Region.

DC, CEOs are having the power to accord Administrative approval upto Rs. 1.00 crore. At present only Micro works upto Rs. 1.00 crores are being given Administrative approval by DC /CEOs. But for the Macro works below Rs. 1.00 crores Administrative approval is given by Secretary, HKRDB.

Further, the Administrative approval and Approval of Tenders for purchase of tools and equipments are presently being given by Secretary, HKRDB even though the amount is within Rs. 1.00 crore.

Therefore in order to bring uniformity in implementation of schemes and thereby better clarity in procedures the following is ordered.

As explained in the preamble, it is ordered that the DCs/CEOs shall give Administrative approval upto Rs. 1.00 crores for both Micro and Macro category of works including both civil works and purchase of tools and equipments, provided that the DPRs for all Macro and Micro Civil works, except those works which follow type design or are of small amount / simple structures, shall be prepared by respective PMCs

appointed by HKRDB. However all works shall be quality checked by the said respective PMCs.

Further provided that the procurement of tools and equipments shall be quality checked through 3rd party Consultants appointed by the HKRDB for the purpose and shall also follow guidelines as per letter no: HKRDB/PLANNING/623/2017-18/10865 dated 21.3.2017.

HKRDB also retains the right to appoint some other department as Implementing Agency for works/ purchases other than DC/CEOs.
