NOTIFICATION

In exercise of the powers conferred by clause 2 of the Karnataka (Special Responsibility of the Governor for Hyderabad-Karnataka Region) order, 2013, the Governor of Karnataka hereby makes, the following Amendments to the Hyderabad-Karnataka Region Development Board Order, 2013, published in part-IV-A of Karnataka Gazette Extra-ordinary dated 6th day of November 2013, namely:-

ORDER

1. Title and commencement.- (1) This order may be called the Hyderabad-Karnataka Region Development Board (Amendment) Order, 2013.

(2) It shall come into force from the date of its publication in the Official Gazette.

2. Amendment of preamble.- In preamble to the Hyderabad-Karnataka Region Development Board Order, 2013 (herein after referred to as the said order), after the words "powers conferred by clause", the figure "2" shall be inserted.

3. Amendment of para 3.- In para 3 of the said order, in sub-para (3),-

(i) for item (b1), the following shall be substituted, namely:-

"(b1) Two members of the Karnataka Legislative Council who are registered as electors in the region for a period of one year by rotation as nominated by the State Government".

(ii) for item (c), the following shall be substituted, namely:-

"(c) One member of the House of people representing a part or whole of the Hyderabad-Karnataka Region whose constituencies lie within the jurisdiction of the Board or a member of Council of State whose name has been registered as voter in the region, for the period of one year by rotation nominated by the State Government".

4. Amendment of para 4.- In para 4 of the said order, in sub-para (1),-

(i) for item (b), the following shall be substituted, namely:-

"(b) All members of the House of people representing the Region;"

(ii) for item (d), the following shall be substituted, namely:-

"(d) All members of the Council of States and the Karnataka Legislative Council whose name has been registered as electors in that Region;"

5. Amendment of para 13.- In para 13 of the said order, for sub-para (2), the following shall be substituted, namely:-

"(2) Subject to the provisions of this Order and the control of the State Government, schemes formulated in accordance with the plans by the development departments, Zilla Panchayat and non-Governmental organizations financed by the Government and recognized by the Board functioning in the Hyderabad-Karnataka Region in respect of the Schemes that are undertaken with the funds

made available to the Board for implementing Article 371J of the Constitution, shall be approved by the Board.

Provided that the Board may, in respect of other schemes like ZP schemes, State plans schemes, Finance Commission grants and similar programmes call for any information from the concerned departments, Zilla Panchayat and non-government organization recognized by the Board financed by the Government and functioning in the region".
